

“The Beast Empire”

There is so much more I could share about “**Mystery, Babylon**”; however, like grains of sand in a hourglass falling so slowly at first but appearing to accelerate with ever increasing speed as those final grains reminds us time waits for no man. This segment shares the legal documentation, history, bloodlines and evidence for the “Beast”. Some have referred to the “Beast” as an “Octopus”, and rightfully so. Recently the head of the House of Rothschild stated that the New World Order would be fully in place next year in 2018. The Rothschild’s have been broadcasting this fact on the cover of their financial/economic publication ‘*The Economist*’. So, if you have been a skeptic through the previous segments as to the reality of this “Beast” who works through those willing to trade their soul for his riches of this world, the following information and evidence ought to awaken you to the fact that in the end their gold, silver, and riches will be not deliver them from the hands of God’s judgment. When the Vatican commissioned the Rothschild’s “Fiduciary Agents” for the Papacy in 1824, the end was drawing near. It was a marriage between the Antichrist and the False Prophet of the Bible.

Nigel’s two-volume work ‘*The House of Rothschild: Money's Prophets 1798-1848*’ is a good starting point for anyone that wants to understand the global “Beast” Empire System. The important thing to remember is that the House of Rothschild is not the power in the world that everyone wants to believe. Authors like Henry Makow like to make the world think the Rothschild’s and Jews in general form all the world’s woes. However, as this study and others

show, the Rothschild's are "bankers" first and foremost, their work is principled on a "commission of 6 percent", and they do not do business with any person, entity, or state for less than \$1-million dollars. The Rothschild's threw their financial backing to Jesuit Adam Weishaupt and his "Bavarian Illuminati" in 1776.

The Rothschild's only have the Bank of England because the Jesuit Order allowed this to happen. Britain was under the Jesuit thumb since the late 18th Century. The Cecil family became subordinate to the Jesuits no later than this and some would say the Cecil loyalties were lacking in the beginning of the 17th Century. This showed as King James I was bought into power over the son of Elizabeth 1st which came from the union of the Queen and Edward De Vere. The Cecil family had the son of that union destroyed and killed, they fitted him up with charges of trying to remove the Monarchy when in fact he was trying to remove the Cecil family. The supposed Puritan-Christian Cecil family soon enough had the Geneva Bible 1560/99 destroyed and replaced with the King James Authorized 1611 Bible.

That was the first phase of the destruction of Christianity and the veiling of exposure of the Catholic Church. All those wonderful footnotes and more removed entirely from the public realm. The Geneva Bible became banned in the Nation by King James I himself. This should ring alarm bells but it does not mean that the King James Authorized Bible is wrong to follow to a point, but the facts are, its missing information of the Geneva Bible.

The Cecil family has been controlled in the region by the Pallavicini family of far greater power and who really funded Queen Elizabeth's war machine. Other families of great power in the region are of course the Catholic Howard and Percy families along with the Powell family. You will find a lot of Powell's have been connected with The Worshipful Company of Mercers. It took many years for the Germanic Bauer family to gain acceptance from the Cecil family of England. Eventually they earned the respect of the Cecil family and a scion was formed. The blood of both families including the Goldschmidt came about such as the line which Kate Middleton is descended from and why she is the wife of Prince William who himself is a Medici, Sforza, Stuart and Guelph.

When the Jesuits were suppressed by the Pope in 1773 they used their covert power over England to have the Rothschild family guardian over the Jesuit South American reductions wealth. The Jesuits could not store this wealth in any Catholic banking house otherwise it would be stolen since the Order was to be destroyed. This is one of the reasons the Jesuits have a stronghold in the United States as the suppression of the Order helped them hoodwink the Reformation Nations even further as you can imagine. What the suppression did do was make the Jesuits even angrier and certainly made them never want to be loyal in the slightest to the Catholic Church again.

It was time to take over the Catholic Church which started in 1814 and was totally complete by 1870 when the Pope was made Infallible. The Jesuits forgot the Holy See generosity of the earlier 14th Century when the Pope allowed a few of these then Knights Templars to survive and live in Aragon. I believe this was why the Jesuits were quite loyal to the

Church prior to the 1773 suppression. The Templars could not continue in Aragon under that old title but of course could become something new. These Aragon Templars became the Order of the Calatrava and Order of the Montesa not to forget the Los Alumbrados meaning the illuminated ones. The current Grandmaster of the current Calatrava and Montesa is Emperor Juan Carlos of the New Holy Roman Empire.

Since this takeover by the Jesuit Order through their 1776 creation of the Order of the Bavarian Illuminati using Giuseppe Balsamo and sheep-dipped Jesuit Adam Weishaupt. The Rothschild's eventually became the Guardians of the Vatican Treasury all thanks to the Jesuit Order. The Rothschild's used the Illuminati Napoleon as an aid in the takeover of the Bank of England which had been created by The Worshipful Company of Mercers. This was to take over of the City of London from the Holy See and the Knights of Malta. The Holy See having controlled the region for a very long time and having handed the control of the region to the Knights Templar in 1215. This had been taken away by the Holy See in 1312 with the "Ad Providam" Papal Bull. So as you can see with a logical thinking mind, the Jesuits have bought back the control of the City of London under the Knights Templar continuum of themselves being the ancient Aragon continuum of the original Order.

The Knights of Malta have never been favorites of the Jesuit Order who never forgive or forget. This hatred of the Knights of Malta increased even further in 1768 when the Knights removed the Jesuits from the Island of Malta. The Jesuits sought their revenge for this one later on in 1798 using their Illuminati-controlled Napoleon. The Jesuits subordinated the Knights of Malta in the same year and that was the true start of the takeover of the City of London which was commanded covertly still by the Knights of Malta. Currently the so-called Protestant division of the Knights of Malta are controlled through the Alliance of the Orders of St John Of Jerusalem by the Order of Malta itself. The Order of Malta being the only true Order out of all of them although its claimed they now recognize the others as part of this Alliance.

This all aided the openness of the Order of Malta to return to England as you can see from their Blessed Adrian Fortescue and later Grand Priory of England in 1993. If you look at St. John's Wood where the Order of Malta are based, you will see it's the old haunt of the Knights Templar in England since the City of London is a sovereign Nation. If you look at one of the four of the most powerful Order of Malta headquarters in Rome you will see that the Aventine Hill is another old Templar haunt which was their original World Headquarters. The Order of Malta has three main bases of power in Italy with a secret forth base which is ever changing and not known to the public, which leads me to believe this is either the true WHQ of the Order or one used for secret commanding only.

Now can one understand the true power over the World and the Bank of England? David Wilcox is part of the Jesuit soldier Frederick Copleston S.J. created conspiracy theory arena known as the so-called alternative media and set up to purposely control the minds of the more intelligent peoples but divert them elsewhere and namely into Jesuit soldier Pierre-Teilhard De Chardin S.J.'s awaiting New-Age Movement pushing the Luciferian Doctrine of the likes of Alice Ann Bailey and Madame Blavatsky. Why would Shimon Peres and his minions give away East Jerusalem to the Vatican in 1993 via Cardinal Ratzinger's Oslo Accords? You know the Accords aided by Georgetown University trained President William Clinton in Jesuit Washington, D.C. The land belonging to the Catholic, Pope and Carroll families being part of Virginia and Maryland giving you Virgin Mary and being known as Rome in 1663 property records. Ask yourself why do those in Israel who opposed the Oslo Accords get whacked or suppressed if they are the supposed power? Enough said, the New Holy Roman Empire rules the World! It's just that simple. Israel is being destroyed by the same Jesuits from the inside out using groups like The Van Leer Jerusalem Institute which is connected with the Beit HaNassi where Pere's dwells funny enough.

Emperor Juan Carlos of the New Holy Roman Empire and Evelyn De Rothschild control your physical being which is your land or your will. They also control your soul and it is all done through the Crown Temple in the City of London connected with the Bank of England. As soon as you are born on Earth if there is a Marriage Certificate they have control over you. If there is not a certificate of marriage but the child is registered to a Birth Certificate then they once again have control over you. The Vatican claims control over you regardless if you study hard enough. The birth certificate ties you into the "Cestui Que Vie Act 1666" [explained further below] and the Vatican Canon Law based Admiralty Law system that's been in place usurping our law of land known as Common Law since 1933. The real push for the Merchant takeover of our lands occurred from 1870 onwards when many definitions of words were usurped with admiralty definitions. Admiralty Law comes from the ancient Phoenician Empire but was perfected by the Roman Empire.

The "Cestui Que Vie Act 1666" goes back to the real root of the problem stemming from 1302 A.D. with the signing of the Papal Bull "*Unam Sanctam*" by Pope Boniface VIII. Also look up the Papal Bull "*Aeterni Regis*" by Pope Sixtus IV in 1481. This, my friends is the complete enslavement of your soul and body being the land. The Vatican controls all the land on Earth and its most important land of all is your will which is your body and thus they control your testament being a product of your will. When you [your birth] are registered a security is placed into the Bank of England of around £1.5 million, maybe more today since that's a figure of around a year ago. This is then traded daily with World-wide banks in a second economy you are not privy too. This secret system is very closely connected with the Universal Postal Union in Bern, Switzerland which is just one corner away from the powerful Papal Nuncio, Archbishop Diego Causero at the Vatican Embassy.

You have become a minor shareholder in the U.K picture but you have no chance of claiming your dividend. This security raises profits which collect over the years of your life. When your will expires as you die then the Escheat Law is bought into play to take all of that

security and profit into the hands of the City of London a.k.a. the New Jerusalem. Your family never ever knew about it and certainly never get a penny of the seriously large sum made. All whilst you were born into slavery working for pittance and struggling to live a decent life. Especially from now on as we enter the zero growth post-industrial society plan signed in by then U.S. President Jimmy Carter. You will be lucky to be able to claim unemployment benefits and forced to jump through hoops to do so and all for a measly £67.50 per week to live on in the new 'peasantville' society fully controlled through the front, the United Nations as time goes by.

This control of the Bank of England through The Worshipful Company of Mercers is what controls the global economy. The U.S. economy is fully controlled by the Mercers and Bank of England and has been since 1868 onwards, some might say since 1861 when America was turned into a corporation by President Lincoln to try to pay off the Mercers for the Virginia Company of London debts for the original Settling of the region. The Jesuits, using both Privy Councilors Roundell Palmer and Edward Stanley, had Lincoln's death warrant signed and executed through the payment of Catholic, John Wilkes Booth through the Bank of Montreal based in Jesuit-controlled Quebec. Wilkes was paid £60 for the assassination and he is an ancestor of Catholic, Cherie Blair the current wife of Knight of Malta, Tony Blair the Catholic crusading war criminal closely tied to the controllers of the Directorate for Intelligence division of the Central Intelligence Agency known as the 'Deutsche Verteidigungs Dienst', the Nazi continuum and major drug trafficking operator for the House of Bourbon and The Worshipful Company of Apothecaries. The City of London controls the U.S. Economy through The City-UK run by Stuart Popham of the Royal Institute for International Affairs, through its U.S. subsidiary The Council of Foreign Relations.

The City-UK controls the Exchange Stabilization Fund commanding the Federal Reserve of New York, World Bank and the International Monetary Fund, the latter of which deals with the Nations bankrupted as of 1933. The City-UK controls the U.S. Treasury which commands all three of those organizations through the Exchange Stabilization Fund. No different to how The City-UK commands the economies of the Middle East through the Middle East Association fronted by Charles Hollis. A powerful family connected to the City of London's control of the United States is the Spring family who took over in the region from the Payseur family who were the French Royal family continuum after the French Revolution. That line is now divided between three other families less significant in the merchant realm to the Spring's. Welcome to the New World Order!

The History of Trusts

The 1st Trust of the world:

"Unam Sanctam" is one of the most frightening documents of history and the one most quoted as the primary document of the popes claiming their global power. It is an express trust deed. The last line reads: *"Furthermore, we declare, we proclaim, we define that it is absolutely necessary for salvation that every human creature be subject to the Roman Pontiff."* It is not only

the first trust deed in history but also the largest trust ever conceived, as it claims the whole planet and everything on it, conveyed in trust.

Triple Crown of Ba'al, aka the Papal Tiara and Triregnum

In 1302 A.D. Pope Boniface issued his infamous Papal Bull "*Unam Sanctam*" - the first Express Trust. He claimed control over the whole planet which made him "**King of the world**". In celebration, he commissioned a gold-plated headdress in the shape of a pine cone, with an elaborate crown at its base. The pine cone is an ancient symbol of fertility and one traditionally associated with Ba'al as well as the Cult of Cybele. It also represents the pineal gland in the center of our brains - crystalline in nature - which allows us access to our Source or mind, hence, the 13-foot tall pine cone in Vatican Square. Think about why the Pontiffs would idolize a pine cone.

The 1st Crown of Crown Land

Pope Boniface VIII was the first leader in history to create the concept of a "**Trust**", but the first Testamentary Trust, through a deed and will creating a Deceased Estate, was created by Pope Nicholas V in 1455, through the Papal Bull "*Romanus Pontifex*". This is only one of three (3) papal bulls to include the line with the incipit "For a perpetual remembrance." This Bull had the effect of conveying the right of use of the land as Real Property, from the Express Trust "*Unam Sanctam*", to the control of the Pontiff and his successors in perpetuity. Hence, all land is claimed as "*crown land*". This 1st Crown is represented by the 1st "Cestui Que Vie Trust", created when a child is born. It deprives us of all beneficial entitlements and rights on the land.

The 2nd Crown of the Commonwealth

The second Crown was created in 1481 with the papal bull "*Aeterni Regis*", meaning "Eternal Crown", by Sixtus IV, being only the 2nd of three papal bulls as deeds of testamentary trusts.

This Papal Bull created the "Crown of Aragon", later known as the Crown of Spain, and is the highest sovereign and highest steward of all Roman Slaves subject to the rule of the Roman Pontiff. Spain lost the crown in 1604 when it was granted to King James I of England by Pope Paul V after the successful passage of the "Union of Crowns", or Commonwealth Act, in 1605 after the false flag operation of the Gunpowder Plot. The Crown was finally lost by England in 1775, when it was returned to Spain and King Juan Carlos I, where it remains to this day. This 2nd Crown is represented by the 2nd "Cestui Que Vie Trust", created when a child is born and, by the sale of the birth certificate as a Bond to the private central bank of the nation, depriving us of ownership of our flesh and condemning us to perpetual servitude, as a Roman person, or slave.

The 3rd Crown of the Ecclesiastical See

The third Crown was created in 1537 by Paul III, through the papal bull “Convocation”, also meant to open the Council of Trent. It is the third and final testamentary deed and will of a testamentary trust, set up for the claiming of all “lost souls”, lost to the See. The Venetians assisted in the creation of the 1st “Cestui Que Vie Act of 1540”, to use this papal bull as the basis of Ecclesiastical authority of Henry VIII. This Crown was secretly granted to England in the collection and “reaping” of lost souls. The Crown was lost in 1816, due to the deliberate bankruptcy of England, and granted to the Temple Bar which became known as the Crown Bar, or simply the Crown. The Bar Associations have since been responsible for administering the “reaping” of the souls of the lost and damned, including the registration and collection of Baptismal certificates representing the souls collected by the Vatican and stored in its vaults. The term “BAR” is an acronym for the British Accrediting Registry. Every U.S. state has a “BAR” association, a franchise of the U.K.

This 3rd Crown is represented by the 3rd “Cestui Que Vie Trust”, created when a child is baptized. It is the parents’ grant of the Baptismal certificate - title to the soul - to the church or Registrar. Thus, without legal title over one’s own soul, we will be denied legal standing and will be treated as things - cargo without souls - upon which the “BAR” is now legally able to enforce under Maritime law.

The Cestui Que Vie Trust:

A “Cestui Que Vie Trust” is a fictional concept. It is a Temporary Testamentary Trust, first created during the reign of Henry VIII of England through the “Cestui Que Vie Act of 1540” and updated by Charles II, through the “CQV Act of 1666”, wherein an Estate may be effected for the Benefit of a Person presumed lost or abandoned at “sea” and therefore assumed “dead” after seven (7) years. Additional presumptions, by which such a Trust may be formed, were added in later statutes to include bankrupts, minors, incompetents, mortgages, and private companies. The original purpose of a CQV Trust was to form a temporary Estate for the benefit of another because some event, state of affairs, or condition prevented them from claiming their status as living, competent, and present, before a competent authority. Therefore, any claims, history, statutes, or arguments that deviate in terms of the origin and function of a CQV Trust, as pronounced by these canons, is false and automatically null and void.

A Beneficiary under Estate may be either a Beneficiary or a CQV Trust. When a Beneficiary loses direct benefit of any Property of the higher Estate placed in a CQV Trust on his behalf, he does not “own” the CQV Trust; he is only the beneficiary of what the Trustees of the CQV Trust choose to provide. As all CQV Trusts are created on presumption, based upon original purpose and function, such a Trust cannot be created if these presumptions can be proven not to exist.

Since 1933, when a child is borne in a State (Estate) under inferior Roman law, three (3) “Cestui Que (Vie) Trusts” are created upon certain presumptions specifically designed to deny

the child forever, any rights of Real Property, any Rights to be free, and any Rights to be known as man or woman, rather than a creature or animal, by claiming and possessing their Soul or Spirit. In short, each of us is a slave. **Do you get this? You are a slave to the Papacy!!**

The Executors or Administrators of the higher Estate willingly and knowingly:

1. Convey the beneficial entitlements of the child, as Beneficiary, into the 1st Cestui Que (Vie) Trust in the form of a Registry Number by registering the Name, thereby also creating the Corporate Person and denying the child any rights to Real Property; and,
2. Claim the baby as chattel to the Estate. The slave baby contract is then created by honoring the ancient tradition of either having the ink impression of the baby's feet onto the live birth record, or a drop of its blood, as well as tricking the parents to signing the baby away through the deceitful legal meanings on the live birth record which is a promissory note, converted into a slave bond, sold to the private reserve bank of the estate, and then conveyed into a 2nd and separate CQV Trust, per child, owned by the bank. When the promissory note reaches maturity and the bank is unable to "seize" the slave child, a maritime lien is lawfully issued to "salvage" the lost property and is monetized as currency issued in series against the CQV Trust.
3. Claim the child's soul via the Baptismal Certificate. Since 1540 and the creation of the 1st CQV Act, deriving its power from the Papal Bull of Roman Cult leader Pope Paul III, 1540, when a child is baptized and a Baptismal Certificate is issued, the parents have gifted, granted, and conveyed the soul of the baby to a "3rd" CQV Trust owned by Roman Cult, which has held this valuable property in its vaults ever since. Since 1815, this 3rd Crown of the Roman Cult and 3rd CQV Trust representing Ecclesiastical Property has been managed by the BAR as the reconstituted "Galla" responsible, as Grim Reapers, for reaping the souls.

Each "Cestui Que Vie Trust", created since 1933, represents one of the 3 Crowns representing the three claims of property of the Roman Cult: Real Property (on Earth), Personal Property (body), and Ecclesiastical Property (soul). Each corresponds exactly to the three forms of law available to the Galla of the BAR Courts: corporate commercial law (judge is the 'landlord'), maritime and canon law (judge is the banker), and Talmudic law (judge is the priest).

What is the real power of a court 'judge'?

Given what has been revealed about the foundations of Roman Law, what is the real hidden power of a judge when we face court? Is it their superior knowledge of process and procedure or of magic? Or is it something simpler and far more obvious?

It is unfortunate that much of the excitement about Estates and Executors has deliberately not revealed that an Estate, by definition, has to belong to a Trust - to be specific, a Testamentary Trust or "CQV Trust". When we receive legal paper or have to appear in court, it is these same "CQV Trusts" which have our rights converted into the property contained within

them. Instead of being the Trustee, or the Executor, or Administrator, we are merely the Beneficiary of each "CQV Trust", granted only beneficial and equitable use of certain property, never legal title. So if the Roman Legal System assumes we are merely the beneficiary of these "CQV Trusts", when we go to court, who represents the Trustee and Office of Executor? We all know that all cases are based upon the judge's discretion which often defies procedures, statutes, and maxims of law. Well, they are doing what any Trustee or Executor, administering a trust in the presence of the beneficiary, can do under Roman Law and all the statutes, maxims, and procedures are really for show because under the principles of Trust Law, as first formed by the Roman Cult, a Trustee has a wide latitude, including the ability to correct any procedural mistakes, by obtaining the implied or tacit consent of the beneficiary, to obviate any mistakes. The judge is the real and legal Name. The judge is the trust, itself. We are the mirror image to them--the ghost--the dead. It is high sorcery, trickery, and subterfuge that has remained "legal" for far too long. Spread the word! **The Biblical "Beast" is the Jesuit Pope of Rome!**

Does the Prieuré de Sion control the Roman Catholic Church today? According to various sources, including the Jewish Encyclopedia, the House of Rothschild has been the long-standing trustee of the Vatican's wealth.

"Early in the 19th century the Pope came to the Rothschild's to borrow money. The Rothschild's were very friendly with the Pope, causing one journalist to sarcastically say 'Rothschild has kissed the hand of the Pope... Order has been reestablished.' The Rothschild's, in fact, over time were entrusted with the bulk of the Vatican's wealth. The Jewish Ency., vol. 2, p. 497 states, 'It is a somewhat curious sequel to the attempt to set up a Catholic competitor to the Rothschild's that at the present time (1905) the latter are guardians of the papal treasure.' Researcher Eustace Mullins writes that the Rothschild's took over all the financial operations of the worldwide Catholic Church in 1823/24. This is true as the Jesuit-controlled Vatican commissioned the Rothschild's to be the Vatican's "Fiduciary Agents". This has never been annulled or abrogated by the Vatican. Today the large banking and financial business of the Catholic Church is an extensive system interlocked with the Rothschild's and the rest of the International Banking system." (*'Top 13 Illuminati Bloodlines'*, p.154)

Eustace Mullins in *'The Curse of Canaan'*, writes on page 125: "In 1715, there were some 415 families in the Judengasse, of whom 109 were money-lenders; there were also 106 hardware dealers; the remaining families were engaged in second hand clothing or fruit businesses. Of the twelve wealthiest families there in 1715, the Speyer's were the richest, having a fortune of 604,000 florins; then came the Goldschmidt's, the Wertheimer's, the Haas family, etc.

4. The Rothschild's, began with 109,375 Florins. Exactly one hundred years later, the Rothschild's were the masters of Europe, dictating the terms at the Congress of Vienna. They then requested a noble coat of arms with a royal coronet, featuring the Leopard of England and the Lion of Hesse. This request was denied in 1817, but after tremendous financial pressure was brought to bear on the government, it was finally granted in 1822. The following year, the Rothschild's took over all of the financial operations of the worldwide Catholic Church. Of the

head of the family, Sir Nathan Mayer Rothschild, the Dictionary of National Biography noted: "The influence of his firm and himself compared with that of the Bank of England. After the death of Sir Moses, Montefiore Rothschild may almost be said to be the generally authorized leader of the Jews of the world."

Fritz Springmeier in his *'Bloodlines of the Illuminati'* writes: "Early in the 19th century the Pope came to the Rothschild's to borrow money. The Rothschild's were very friendly with the Pope, causing one journalist to be sarcastic and say *"Rothschild has kissed the hand of the Pope...Order has at last been re-established."* The Rothschild's in fact over time were entrusted with the bulk of the Vatican's wealth. The Jewish Ency., Vol. 2, pg. 497 states, "It is a somewhat curious sequel to the attempt to set up a Catholic competitor to the Rothschild's that at the present time (1905) the latter are the guardians of the papal treasure." Researcher Eustace Mullins writes that the Rothschild's took over all the financial operations of the worldwide Catholic Church in 1823.

Today the large banking and financial business of the Catholic Church is an extensive system interlocked with the Rothschild's and the rest of the International Banking system. The great wealth of the Russian Czars was entrusted to the Rothschild's, \$35 million with the Rothschild's Bank of England, and \$80 million in the Rothschild's Paris bank. The Rothschild's financed the Russian Revolution which confiscated vast portions of the Orthodox Church's wealth. Due to their power, they have been able to prevent the legitimate heirs of the Czars' fortune to withdraw a penny of the millions deposited in a variety of their banks. The Mountbattan's, who are related to the Rothschild's, led the court battles to prevent the claimants from withdrawing any of the fortune. In other words, the money they invested in the Russian Revolution, was not only paid back directly by the Bolsheviks in millions of dollar of gold, but by grabbing the huge deposits of the Czars' wealth, the Rothschild's gained what is now worth over \$50 Billion." All of the preceding information is the legal basis for Papal enslavement of humanity. There is no easier way to tell you are a slave without the details of the Laws in effect in perpetuity.

There are certain sources in the Council of Foreign Relations and Trilateral Commission that want things that are going on known to people. There has been knowledge given as to what the international Bankers intend to do worldwide. There is one very powerful group of people who literally hold the money control of every nation in the world. They control most all the world governments through finance. And for all intents and purposes they are the sole government of the world, even at this time. You possibly have not realized that fact as of yet, but you will. As you know from a previous chapter in Nigel's book the Federal Reserve System is an individually owned corporation and it controls the money, the interest rates, the general economy and the daily market prices of gold and silver. It is NOT an agency of the United States Federal Government and it never has been! It is a privately-owned corporation.

Supposedly, thirteen families which are thought to control the central banks and the hard currency countries of the world rule on behalf of the Papacy. It is commonly thought that they own the majority of the stock and control the regional banks of the Federal Reserve

System. It is proven knowledge that anytime someone or a group of people are involved in the organization of a scheme, they use sacrificial lambs for the public viewing so that the person or persons that are orchestrating the whole show are never seen or known. This is the case with the Federal Reserve System in America, which has interlocking controls globally because it is all part of one parent that traverses the globe. And there is a monopoly held for Railroads and Banking. All of the people and banking houses that appear to be separate entities are all part of this parent; how they became involved goes all the way back to the early 1800's and the great grand-parents in the family bloodline that were hired by the Payseur family to become life estate Trustees, based on 99 year leases and Trusteeships expiring June 17, 1993 and December 31, 1993, for certain banks and corporations that reach around the globe. All these families were trustees for the Payseur conglomerate. These Trustees do not really own these corporations or banks; they are all in Trust.

The group of their Trustees listed below control the policy-making and decision making of the central banks of the leading nations of the world.

One short note about the Rothschild's at this time, the last bank mogul and tyrant of the Rothschild's was murdered sometime in 1990 and there is someone else controlling now, not a Rothschild. He was found hanging from a bath shower fixture.

The above-listed banking houses, to an extent, manipulate the daily prices of gold and silver on the exchange. The hard currency countries are those countries whose currency is not allowed to fluctuate as much as the other countries' currency fluctuates. The American dollar is the standard for all of the currency in the world.

Wherever the American dollar goes, it affects other nations in relation to our dollar. These corporations, banks and railroads reach into almost every country of the world at this time; they have control of these countries. They practice fractional reserve banking.

For nearly 700 years the papacy ruled as a church-state power until 1870 when the new government of the state of Italy (formally established in 1861) seized the "papal states," which included Rome. Pope Pius IX went into self-imposed imprisonment within a few buildings in central Rome. This wiped out the church-state hierarchy of the Catholic Church but not the Catholic Church. Vatican I was called during this period and some of the most sinister decisions regarding the church, its power and future plans were developed, including the concept of papal infallibility.

To prevent remonstrance (a formal statement of grievances) against the newly formed government, Italy passed a law entitled "Law of Papal Guarantees" on May 13, 1871. It granted the pope sovereign honors and full freedom to exercise his spiritual authority, the right to receive and send ambassadors, with some minor territorial usage rights in Italy – plus a salary. Pope Pius IX refused to acknowledge this document. Immediately, the relationship between the Italian government and the Roman Catholic Church began to deteriorate. By May, 1873 the Italian chamber of deputies invoked an 1866 law, taking over all religious orders, Catholic schools and hospitals throughout the country. That is when a serious blow came to the papacy.

It was during this period of civic isolationism that Pope Leo XIII (1878-1903) came into power. He developed an official position on religious liberties and church-state relations, which demanded that states must not only care for religion but must "*recognize the true religion professed by the Catholic church.*" He was powerless to enact this and other dictums that evolved during this time. It wouldn't be until Vatican II that they would implement this groundwork, which included "plans" to first coerce America and later the world.

On February 11, 1929, the Lateran Treaty and Concordant between the Vatican and the kingdom of Italy was signed, which established the autonomy of the Holy See as a church-state. On June 3, 1985, the Vatican and Italy ratified a new church-state treaty known as a "concordat," which replaced the Lateran Pact of 1929. Though reported as a downgrade of Catholic power and papal influence, it actually gave greater international flexibility. To that point the original treaty declared Roman Catholicism as the state church of Italy. By separating from this, along with other legal stances, the Vatican – Holy See stands more independent without legal ties to Italy. This now opens the door for it to become a full-fledged member of the United Nations (U.N.) with the question of religious issues lessened. Also, Rome ceased to be declared in the concordats as a "Holy City."

The Holy See has been registered as a "Non-member State Permanent Observer" of the U.N. All other world religions serve as NGO's or non-governmental organizations. Because of the rarely-used designation granted to the Holy See, it has privileges of a state like no other church has. It can speak and vote at all U.N. conferences. No other religion has this elevated status. Because U.N. conferences operate on a consensus, the ability to disagree with the major consensus gives it significant power. It is most intriguing that the General Assembly never took a vote on the presence of the Holy See at the U.N.

The Vatican is not registered with the United Nations as a state but as the Holy See. By definition the Holy See is a non-territorial religious entity. It is not a state but the hierarchy of the Roman Catholic Church.

Switzerland had been in a Permanent Observer status, but in February of 2002 they became a full-fledged U.N. member. The Vatican is now the only Permanent Observer "organization" not yet admitted as a full member of the U.N.

The Vatican is situated on 108 acres and is a true sovereign state with citizenry, courts, police force, postal service and ambassadors. It is seen as a separate “nation.” Yet, its U.N. ties are totally religious. It fronts its religious face in order to influence political power. People look to the Vatican, not because of its vast military, economy or potential for commerce; they come in the hope to have contact with one of the most charismatic individuals in the world – the pope. He has enormous stature on the world scene.

Critics contend that on some issues he is too theologically conservative for the times, but the steady parade of world leaders has made it plain that he is a man to be reckoned with. There are few experiences, even for a world leader, as daunting as being escorted through the elaborate halls of the Apostolic Palace. Along the way, thousands of years of history and power make their impression, even before the leader lays his eyes on the pope.

A world leader is received by the pope in the private library. Here they will exchange gifts and read statements typical of any state visit. But the Holy See is a religious state, and that means there are variations on normal diplomatic protocol.

The Roman Catholic Church first officially participated at the United Nations when the Vatican City was invited to the United Nations conferences because of its membership in the Universal Postal Union and the International Telecommunication Union. In 1957, through an exchange of letters, the Holy See and the Secretary-General of the United Nations agreed to refer to the Papal delegation at the United Nations as the “Holy See.” Finally, on March 21, 1964, Pope Paul VI established the first Holy See ‘permanent observer’ mission at the United Nations. As a result, the Holy See is regarded as a ‘non-member state’ permanent observer....

The status of a permanent observer places restrictions upon an entity’s role at the United Nations, and these limitations generally vary according to the type of permanent observer status. There are no provisions in either the United Nations Charter or the Rules of procedure of the Economic and Social Council (‘ECOSOC’) that specifically refer to the participation of non-United Nations members in ECOSOC meetings. However, non-member state observers have been invited to participate in meetings discussing matters of concern to those states. Since the Holy See is a permanent observer, it cannot cast a vote in the General Assembly of the United Nations. But permanent observers have sometimes participated, on an ad hoc basis, in General Assembly discussions and decisions. The Holy See has participated in the General Assembly on several occasions. Pope Paul VI addressed that body on October 4, 1965, and Pope John Paul II did so on October 2, 1978. Pope Francis addressed the United Nations in September of 2015. The Permanent Observer for the Holy See addressed the Tenth Special Session of the General Assembly Devoted to Disarmament.

In a legal sense the Holy See is a religious body represented at the U.N. Examination of its entry into the U.N. shows it achieved its exclusive position without meeting the proper criterion on member votes. It is quietly trying to achieve full status as a Non-member but not as the Holy See but as the Vatican, the official state! If it achieves this status and remains as a Holy

See Permanent Observer, then it will be an achievement like no other in world politics, power or deceptive maneuverings has ever attained.

As all this moves forward, “The Roman Catholic Church is uniquely positioned to influence international policy-making. It speaks on issues of concern for its religious following to numerous nations around the world. At the international level, the Roman Catholic Church uses its distinctive position at the United Nations to affect a wide range of global issues, including international economic development, women’s status, population, and family planning....

The Holy See’s status at the UN entitles it to many of the same privileges enjoyed by governments. Yet, the Holy See lacks traditional citizenry of its own. The Holy See speaks at the UN not as a nation-state addressing the pressing concerns of its citizens, but as a religion seeking to exert its version of morality on Catholics and non-Catholics alike. All of the other religions of the world are entitled only to the limited privileges of non-governmental organizations within the UN. The Roman Catholic Church therefore enjoys a unique degree of international political leverage typically reserved for governments....

The Holy See serves as ‘the supreme organ of government of the [Catholic] Church,’ with the Pope designated as its head in the Code of Canon Law. It is, by definition, a non-territorial religious entity. The Holy See consists of the Pope, the College of Cardinals, and the Roman Curia – the departments and ministries that assist the Pope in the government of the Church. The Pope possesses supreme authority within the Church, and no one may appeal his decisions or decrees. The Pope’s authority rests on moral and spiritual principles and is not enforced by civil penalties.

Widely regarded as a ‘vassal’ territory of the Holy See, the Vatican City exists solely to provide a base for the central administration of the Roman Catholic Church. Only 0.44 square kilometers in size, the Vatican City is the smallest area in the world that claims statehood.

Yet the Vatican is constantly interfering in American politics without any threat of congressional investigation. And such intervention occurs not only in the United States but across the world. Since the Vatican’s intervention is almost as top secret as the CIA’s, it is discerned through a study of the men who advise the President of the United States; those who write public policy and through the process of codification into rules and regulations. As an example of what I am referring to is found in a picture of President Obama sitting in the Oval Office, surrounded by his National Security Council, and every person in the group were in one way or another connected to Jesuit Georgetown University.

It is obvious from such intervention in foreign and domestic policy and in its opposition to both contraceptives and abortion, that the Vatican views itself as the fulfiller of a theocratic world state, with the authority to tell legislators in democratic nations what they must or must not legislate.

If someone argues that the church is merely engaged in moral instruction, it is essential to note the distinction between a civil state and a church. In the United States, the Constitution requires the government to 'promote the general welfare;' not just the welfare of those approved by the Vatican. Moreover, the Vatican is not just a church; it is also a state ruled by the same people who rule the church....

It also means that the Vatican claims representation in the United Nations and functions like a nation-state in international gatherings at the same time that it functions like a church. Yet, American politicians would never investigate the Vatican's numerous attempts to influence or control American foreign or domestic policy because, like a chameleon, it would claim it was merely functioning as a church, not as a state. In fact, it is already so powerful that anyone who tried to investigate it would find such an endeavor a political liability.

All this is evidence why political ecumenism is a real danger. Progressive Catholics and non-Catholics must examine every proposal by Catholic bishops and Catholic politicians with unusual scrutiny as to whether they will move us ever closer to a theocratic state – quite like the state advocated by such Protestant right-wing groups as the Christian Coalition, Promise Keepers, Focus on the Family and James Kennedy's Coral Ridge Ministries. There is some evidence that they may already be in bed together.

Quietly and imperceptibly the influences of the Roman Catholic Church increases. It has, since 1985, positioned itself in such a way it can play its church or state influence at will. It is manipulating governments through social issues. Politicians are increasingly sympathetic to its demands because nearly everywhere they have Catholic constituents. The stage is being set for the assumption of power, which the Bible says will come. It will be supported by the U.S. government in unprecedented control to finally achieve a theocratic end one could easily call a tyranny. All that said speaks to the "Mystery" attribute in Revelation 17:5: ***"And upon her forehead was a name written, MYSTERY, BABYLON THE GREAT, THE MOTHER OF HARLOTS AND ABOMINATIONS OF THE EARTH."***

In my series "The Truth Shall Make You Free", in Part 19 I shared a photocopy of a Federal Reserve Lien against the United States in the amount of \$14.3 Quadrillion proving the IRS owns all land, real estate, and every last human being on the records. The “United Nations” is a singularly unique thing in the world. Here are some truly stunning facts about the United Nations:

1. The United Nations was established on [October 24th, 1945](#).
2. Only Warring “Allied” nations qualified to join the United Nations in the beginning, and some nations declared war retroactively to join and be seen as belligerent and combative (a form of legal incompetence).
3. Germany surrendered to the “United Nations” on **May 9th, 1945** and was made retroactive to May 8th, months before the United Nations was officially established.
4. The [German Instrument of Surrender](#) made the German Nazi Government the First unofficial Member of the United Nations, which was then “dissolved.”
5. The [United States deposited their ratification](#) of the United Nations Charter on **August 8th, 1945**.
6. [Japan surrendered to the “United Nations” on September 2nd, 1945](#) for dissolution, making it the Second unofficial member of the United Nations before establishment.
7. The United Nations replaced the League of Nations (LoN) because the LoN was found to be morally and organizationally bankrupt in preventing war.
8. The League of Nations was officially dissolved and assets returned to the former member countries.
9. The League of Nations Receivership authority appears to have been transferred to the United Nations; and the UN seems to be the League of Nations operating in bankruptcy receivership.
10. The United Nations has multiple complexes around the world, such as a Headquarters in the old League of Nations “**Palace of Nations**” Headquarters.
11. The United Nations requires all joining Nations to be operating in Bankruptcy Receivership and to SURRENDER (a term of war) the Trusteeship to the United Nations.
12. The Head of the United Nations is titled the SECRETARY-GENERAL. A General is a military position that keeps secrets.

13. All UN Member-Nations have entirely LOST their sovereignty to the United Nations and are merely operating (as executors) the “national Trust” Franchise set up to look like a “nation” which is called “the Public” by [fictitious] attorneys.
14. The United Nations is the single global issuer of “legal presences” (which are artificial persons/strawman) for all UN Member Nations and requires the “UN Member-Nation” to Surrender (term of war) the Birth Certificate to the United Nations to be able to access its “CITIZENS” legal presences from the UN.
15. The [United Nations grants total immunity for the operations, execution, and performance of their UN Member-Nation Franchise](#). 17. **UN Competent National Tribunals** are not required to abide by any National Laws and are all extra-territorial courtrooms in the appearance of “justice” but not actual justice.
18. The United Nations grants its “UN Member-Nation” franchises the “sovereign right” to control all “Citizens” legal presences and all Human Being Nationals. This has led to every UN Member-Nation being and acting like an open air prison.
19. Pets are CONTRABAND and may be murdered by corporate policy enforcers unless they are “UN Member-Nation licensed”; and thus owned by the UNITED NATIONS. Contraband only applies to CORPORATE PRISON SYSTEMS.
20. All Nationals are controlled by the United Nations by placing them into a “National Trust” for being “stateless.”
21. The Highest Law of the Land is the United Nations Universal Declaration of Human Rights (UN-UDHR) and it supersedes all national constitutions, national laws and codes, and every nation.
22. The UN-UDHR is/was imposed as a Corporate Legal Franchise *OVERLAY* via the *Power of Assumption* by the UN. Assumption is a Legal “power” that allows the Executor (usually the “UN Member-Nation”) to operate under any assumption they want to impose without having to provide any evidence of the assumption’s actual truth and accuracy. It makes the “UN Member-Nation” into an Open Air Prison System Franchise.
23. The UN-UDHR allows the United Nations to entitle and Underwrite (with IMF debt) all human rights merely for claiming to be a human being and/or to have/exercise any human rights. Our Human Body and Human Rights are the value/surety backing the fictional legal franchises.

- 24.** The Land for the United Nations buildings was donated by John D. Rockefeller Jr.
- 25.** The Treaty from June 26th, 1947 (between the United Nations and the United States) that headquarters the United Nations in New York City – granted the whole of the CITY OF NEW YORK to the United Nations, along with radio facilities and an airport. The City of New York is its own Sovereign City-State just like the Vatican City, City of London, City of Washington, and CERN.
- 26.** The John F. Kennedy Airport was opened in 1948 in accordance with the United Nations Treaty with the United States in #25.
- 27.** Title 22 U.S.C. §4309a (e) United States responsibilities for employees of the United Nations provides that the US Secretary of State defines the “UNITED NATIONS HEADQUARTERS DISTRICT” but refuses to clarify the operational definition. The UN Headquarters District seems to be all of the City of New York: Manhattan, Bronx, Queens, Brooklyn, Staten Island, and U Thant Island.
- 28.** Residents born in a Federal Zone such as City of Washington, Guam, Virgin Islands, Puerto Rico, etc. are NOT eligible for US Presidency because the operational incorporated “UNITED STATES” is only the 50 incorporated states.
- 29.** The City of New York issues their own Birth Certificates and Vehicle Titles separate from that of the STATE OF NEW YORK, just like the City of Washington, City of London, and the Vatican City.
- 30.** DONALD J. TRUMP was born in the CITY OF NEW YORK, DONALD J. TRUMP’s City of New York Birth Certificate is not related to the State of New York in any way; making him ineligible to be President of the United States as the CITY OF NEW YORK is not a land territory of the United States.
