

# **“The Truth Shall Set You Free”**

## **Part 5**

The “Black Nobility” or “Black Aristocracy” are Roman aristocratic families who sided with the Papacy under Pope Pius IX after the Savoy family-led army of the kingdom of Italy entered Rome on September 20, 1870, overthrew the pope and the Papal States, and took over the Quirinal Palace, and any nobles subsequently ennobled by the pope prior to the 1929 Lateran Treaty. For the next 59 years, the pope confined himself to Vatican City and claimed to be a prisoner in the Vatican to avoid the appearance of accepting the authority of the new Italian government and state. Aristocrats who had been ennobled by the pope and were formerly subjects of the Papal states, including the senior members of the Papal Court, kept the doors of their palaces in Rome closed to mourn the pope’s confinement, which led to their being called the “Black Nobility”.

The election of the very first Jesuit pope – Francis Xavier, plays a key role in the last days as does his abominable order, the Society of Jesus. I have studied the Roman Catholic Institution for five decades. In the process, my research has uncovered the machinations of the New World Order and their “thousands of conspiracies operating in tandem”. The missing link in this global puzzle that completes this mystery is the various Catholic Orders, but particularly, the Jesuits. The Jesuits are the primary architects of the New World Order. They themselves created the Bavarian Illuminati which is known today as the modern version of the Illuminati.

The Jesuits were the power behind Hitler’s Nazi Germany and its final solution for the Jewish people. There exists today a hidden history which can be revealed beneath massive amounts of documentation. This is not a conspiracy theory but clear evidence which proves and links a satanic agenda to the Jesuits and the Papacy. The fact is that most of it has been suppressed or has not been given a voice and so it continues to remain largely hidden from the public.

Much of this evidence can be learned by reading the ground-breaking expose ‘*Vatican Assassins*’ by Eric Jon Phelps or ‘*The Grand Design Exposed*’ by John Daniels. Both sources reveal historic evidence of Jesuit complicity in most of the European wars and assassinations of heads of state (including U.S. presidents). You soon realize that the Jesuits are duplicitous but operate quietly from behind a curtain of secrecy. There is ample factual detail showing that the real Society of Jesus is a Luciferian Occult Organization with connections to the “Black Nobility” and the “Committee of 300”.

The core facts reveal that the Jesuits are not only part of the occult based web of secret societies and New World Order groups but is in fact the puppet-master behind them. Numerous testimonies from statesmen and

national leaders have repeatedly warned of the Jesuit's power and their drive for world domination.

A book written by Bill Hughes titled *'The Secret Terrorists'* is another important read to educate yourself on the unparalleled power of the Papacy and the Jesuit Order. It documents the Jesuit plots behind the establishment of America's first three central banks, the assassinations and attempted assassinations of not only Abraham Lincoln, but Presidents, Andrew Jackson, William Harrison, James Garfield, William McKinley, and John F. Kennedy.

His book documents the Jesuit agenda to overthrow the U.S.A. through control of the Freemasons and International bankers. Hughes quotes a letter penned by Abraham Lincoln to his friend Charles Chinquy in which the President believed the Jesuits were plotting his assassination. Not many are aware that while on his way to his inauguration, Abraham Lincoln was made aware of a Jesuit plot to murder him in Baltimore even before he took office. Quick measures had to be taken to prevent this from happening.

It is seldom recognized that the Rothschild Dynasty (the richest family on earth) is the guardian of the Vatican Treasury which includes the Imperial Treasury of Rome. Although they themselves are believed to be Jewish, they are in actuality Jesuit-controlled. In 1823-1824 the Rothschild's were commissioned by the Vatican to be its "Fiduciary Agents". The Red Shield used by the Papacy armies became symbolic of the victorious Church. The Council of Trent openly preferred the Jesuit Order (a military order) above all other Catholic Orders. Rothschild is German for "red shield". Their facade is ingenious and cleverly disguised. Who would ever look into the finances of an Orthodox Jewish family (in appearance) for managing the financial dealings of the Jesuits?

Most conspiracy researchers believe the Rothschild's are the power behind the Federal Reserve, but the real power comes through the Vatican Bank. The Jesuit controlled Vatican and its Papacy is the power behind Freemasonry, the Illuminati, the Knights of Malta, the Knights of Columbus, Opus Dei, the Bilderberg Group, the Council on Foreign Relations, the Trilateral Commission, the Royal Institute of International Affairs, and numerous other groups including the infamous banking cartel of the Federal Reserve System.

The Jesuits are a front for the "Black Nobility" which is named such for their ruthless lack of scruples. They have employed murder, rape, kidnapping, assassination, robbery, and all manner of deceit on a grand scale and they will stop at nothing to attaining their objectives. It's no secret that money buys power and these family bloodlines all possess immense wealth. The most powerful of the "Black Nobility" families are located in Italy, Germany, Switzerland, England, Denmark, and Greece in that order. Their roots can be traced back to the Venetian oligarchs, who are of Khazar

extraction and married into these royal houses in the early part of the 12<sup>th</sup> century.

Following a great Khazar victory over the Arabs, the future Emperor, Constantine V, married a Khazar princess and their son became Emperor Leo IV (also known as "Leo the Khazar"). The Medici popes, and Pius XII (Eugenio Pacelli) were Khazars, as was Pope John Paul II. Not all "Black Nobility" are from royal houses, and many of the royal families no longer have physical kingdoms. According to researcher and author Dr. John Coleman, a "Committee of 300" was established early in the 18<sup>th</sup> century, although it did not take on its present form until 1897, when the China opium trade was legalized. Dr. Coleman published his book *'The Committee of 300'* in 1993. In it, he completely exposes the hidden agenda of this globalist New World Order.

Writing in the December 24, 1921 Wiener Press, socialist politician and financial adviser to the Rothschild's, Walter Rathenau revealed, "Only 300 men, each of whom knows all others govern the fate of Europe. They select their successors from their own entourage. These men have the means in their hands of putting an end to the form of State which they find unreasonable".

Exactly six months after publication, Rathenau was assassinated. Dr. Coleman's work opens the door to further studies on named members of the ruling elite, particularly in America. The English have a long history and are very aware of their ancestry, whereas certain families of "Blue Bloods" in the United States have historic ties with the English through blood and money.

These "Nobility" families are behind most, if not all of the so-called pro-environmental movements that are actually intended to curb the population growth of ALL nations. Prince Philip and Prince Charles are the most visible symbols of this movement, and are a true part of this conspiracy to destroy industry and take the world back to a New Dark Age. I prefer to call it Neo-Feudalism and have done so since 2007.

Most, if not all of the crowned and uncrowned heads of these dynasties enjoy huge incomes from ground rents. All of this group favor the *Global 2000 Report to the Presidents* which was commissioned by President Jimmy Carter on May 23, 1977. The report was released at a press conference in the White House Press Room on July 24, 1980. It was the first (and to date the only) effort by a nation to prepare a 20-year outlook on probable changes in the world's population, resources, economy, and environment. It is calculated to end all industrial progress, and by famine, disease and wars to eliminate the excess population industry supports. All compose nuclear power that can produce clean cheap electricity, the key to economic development and prosperity in the Third World. They ardently desire a return to the feudal system where they will once again be absolute rulers.

While professing Christianity, the oligarchical families, for the greatest part, actually secretly despise it. Masonry provides them with their need for religious fulfillment, as Masons learn in the 19<sup>th</sup> degree their god is Lucifer of the Bible. Without faith they have no belief in reward or punishment and a world to come. They live for the here and now. They will produce for the world an Anti-Messiah, in the name of Prince William, son of Prince Charles and Princess Diana. I'll come back to this later and provide the background on this fraud, and how they intend to fool the world. Do not scoff at the idea of Prince William from what you may know about him.

Like so many of the world's banks, many of these oligarchies are in the drug and arms trade through well-distanced intermediaries.

In 1815 the Jesuits and their Freemason allies among the crowned heads of Europe held the Congress of Vienna, whereby Swiss neutrality (already sanctioned by the Peace of Westphalia in 1648) was forever guaranteed, and no matter how many wars are provoked in which the common man has to do the fighting, the money of the Nobility in Switzerland should always be free from plunder. This arrangement was part of Rothschild's meticulous long-range planning, and why Switzerland exists to this day. But that isn't meant to say your money would be safe. Some \$280 billion U.S. dollars in flight capital and drug money flows into the Swiss accounts of the "Black nobility". Freemasonry's place in the power structure of the elites is quite evident as they have carried through Adam Weishaupt's conspiracy to avenge the Jesuits after their abolition in 1773 by Pope Clement XIV who died in 1774. I will be sharing more on Adam Weishaupt as this series continues. At the time of their suppression, the Society of Jesus (Jesuits) were viewed as immoral and "a menace to the Church and the Faith". The French Revolution of 1789-1799 was a fight not only against feudalism and the French monarchy, but also against the Church. The French Revolution and the spread of the anti-Christian Cult of Reason were the result of Jesuit, Masonic, and Illuminati influence. By launching the French Revolution and directing Napoleon's conquest of Catholic Europe, and by revolts against the church in Mexico and Latin America, they succeeded in cutting-off Vatican income.

Nathan Rothschild financed Britain in the Battle of Waterloo which resulted in the defeat of Rome's enemy Napoleon, as well as becoming the source of his wealth and influence. A Papal decoration was bestowed upon Kalman Rothschild by Pope Gregory XVI for loaning the Vatican five million pounds during a period of financial difficulty. The Rothschild's have been the "Fiduciary Agents" for the Vatican since 1823-1824. With Vatican interests at heart, the Rothschild's expanded their financial and political dominion into the United States.

The Vatican's interest in the United States was clearly revealed in the 1822 secret Treaty of Verona between Austria, France, Prussia, and Russia whereby the Jesuit Order pledged itself as the price of reinstatement to

destroy "the works of Satan" it had established in setting-up, by revolution, representative governments such as the republics and "democracies" of France and the USA, replacing them with the only form of government approved by the church, rule by "divine right", as declared by the Vatican - (read Daniel 2:42-43 and Revelation 17:12-13).

As Senator Robert Owen pointed out to the U.S. Senate in 1916, the prime target to which the Vatican and the "Holy Alliance" (Treaty of Verona) directed the subversion and destructive activities of the Society of Jesus is the United States, and other republics in the Western hemisphere. This plot, he claimed, was the target at which the Monroe Doctrine was directed. The Monroe Doctrine is the best-known U.S. policy toward the Western Hemisphere. Buried in a routine annual message delivered to Congress by President James Monroe in December 1823, the doctrine warns European nations that the United States would not tolerate further colonization or puppet monarchs. The doctrine was conceived to meet major concerns of the moment, but it soon became a watchword of U.S. policy in the Western Hemisphere. What the Senator did not realize is that the Monroe Doctrine protects the interests of "The City of London" or what is known as the "Crown Corporation". <https://www.youtube.com/watch?v=r2TrTsmJU2s>

The Rothschild-Vatican cabal unsuccessfully attempted to gain control over the power of the purse in the United States through the First and Second Bank of the United States. They were established under emergency powers granted to the Presidents by the Constitution, as temporary institutions to tide the country through the periods of financial stress occasioned by the Revolutionary and 1812 Wars. But the aims of the conspirators to establish a banking monopoly were thwarted by the Constitution. That was until the signing into law of the Federal Reserve Act of 1913.

It is said the Black Nobility promised a neutral Germany if Soviet Russia allowed East and West Germany to reunite and Russia promised to see that all royal houses were restored to the rightful heirs if they decouple Europe from the American Alliance.

Imperial nobility enjoyed a more elevated status than the nobilities of the German successor states and, indeed of the Italian states. The descendants of the Italian Holy Roman Empire titles have formed an Association to which all male line descendants of someone ennobled by Imperial Patent is entitled to belong. And the Principality of Liechtenstein has also claimed the ability to confirm a succession to imperial titles, and has confirmed the right of a Spanish noble man to heir such a time for purposes if the Spanish law requiring the successor state to confirm that the claimant to a particular title is in fact the heir. Thus there is a remaining jurisdiction, even though no imperial titles have been conferred since 1806. In 1963, the Holy Roman Empire Association was established to unite male descendants in its membership who are invested with nobility of the Holy Roman Empire.

It also includes a number of honorary members. The “Black Nobility” belongs to the “Committee of 300” that controls the U.N.

Prince Bernhard of the Netherlands has the power to veto the Vatican’s choice of any pope it selects. This may explain the untimely end to Pope John Paul I’s 33-day pontificate. The Prince has veto power because his family, the Habsburgs, are descended directly from the last Roman emperor. The Habsburg Frederick III was the last emperor to be crowned in Rome; his great-grandson Charles V was the last to be crowned by a pope. This is the civil requirement of the pope’s claimed “apostolic succession” from Saint Peter. Truth be known, there were no popes for the first couple hundred years of Christianity, and the Apostle Peter remained in Jerusalem for most of his years ministering to the Jewish Christians. The disciple Peter never ministered in Rome. The fake Simon Magus tried to buy the power of the Holy Spirit, noted in Acts 8. Being driven from the presence of the original disciples, Simon Magus fled to Rome where he set up his own church, becoming the so-called first pope centuries later.

Prince Bernhard’s House of Orange had its origin in France. The Habsburgs are related through marriage with the Merovingians, who are said to have descended from the Israelite Tribe of Benjamin who went into exile following a war with the other eleven Tribes (see Judges chapter 21). Their exile took them to Arcadia in the central Peloponnese islands of Greece.

Here they aligned with the Arcadian royal line and towards the advent of the Christian era, migrated up the Danube and Rhine rivers, and through marriage engineered the Sicambrian Franks – the immediate forebearers of the Merovingians, who were ultimately of Semitic origin, and descendants of King Saul.

They are identified with the Spartans, and both books of Maccabees link the Spartans with the Jews. 1<sup>st</sup> Maccabees 12:21 tells of Jonathan sending a letter to the Lacedemonians (Spartan Greeks) asking them for help, since they were brethren. The Spartans replied, *“It is found in writing, that the Lacedemonians and Jews are brethren and that they are of the stock of Abraham”*

It is assumed by some writers that this means the Spartans were Israelites, but the Spartans were not Israelites they were Edomites descended from Bela son of Beor and brother of Baalim, and king of Edom – (Genesis 38:32; 1<sup>st</sup> Chronicles 1:43). Edom was the son of Isaac and grandson of Abraham who sold his birthright, and bred his posterity off the Book of Life.

Early in the fifth century the Merovingians established themselves in what is now known as Belgium and northern France. There they adopted the Cabalistic pseudo-Christianity of the Cathars, a dualistic religion that holds there are two eternal gods, the god of Good and the god of Evil. It is interesting that this Luciferian belief is held by Freemasonry of the high

degrees and those who would be Masons of this world today, and who claim that Lucifer will ultimately be victorious.

Under Clovis I, who reigned from 481-511 A.D., the Franks converted to Roman Catholicism. Through him, Rome began to establish undisputed supremacy in Western Europe. In return for being the sword of Rome whereby the church would manifest her power and impose a spiritual dominion, Clovis was granted the title of “New Constantine” and to preside over a unified “Holy Roman Empire” based upon the church and administered on the secular level in perpetuity by the Merovingian bloodline. Like “the sure mercies of David”, this was a pact that could be modified, but not revoked, broken, or betrayed.

The “Black Nobility” believe that Jesus Christ survived the cross and married Mary Magdalene who bore His son and then lived in seclusion in the south of France. Laurence Gardner’s book, *‘Bloodlines of the Holy Grail’* teaches that Jesus had two sons and a daughter. His book makes a case that the False Messiah, the Antichrist, will come from the British Royal Family. The general consensus within the “Black Nobility” is that the family with the most “so-called” blood of Jesus, will bring forth the Antichrist.

The issue that Jesus Christ survived the crucifixion is pure nonsense, and has been repudiated by history, medicine, theology, the Biblical record, and by other evidence as well.

Scripture clearly states that a Roman soldier ran a spear through the rib cage and into the heart of the body of Jesus Christ. The Gospel of John 19:34 states that blood and water came forth when the soldier ran his spear into the torso of the Lord Jesus Christ. That event would have been terminal in every possible way. Medical experts have tried to determine what was punctured to create a flow of blood and water. Some think the pericardial sac was ruptured. The mention of the blood and water also answers the argument by some that Jesus did not really die but fell into some type of coma from which he later awakened in the tomb. But the eyewitness account of the blood and water refutes that. The piercing itself would have killed Jesus, but he was already dead as the separation of blood and water reveal. Jesus did indeed die a human death. In addition, the Roman soldiers, who had participated in numerous crucifixions, reported to Pilate that Jesus was dead.-(Matthew 15:44-45) Thus, the “Black Nobility” basis for “Divine Right of Kings” is totally nonsense. Their so-called “Divine Right of Kings” is a myth, a fabrication to lord it over the peasants.

I would note here that the most important books ever published on the future Anti-Messiah or Antichrist being of the British Royal Blood Line are:

- *‘The Antichrist and A Cup of Tea’* by Timothy Cohen
- *‘Bloodline of the Holy Grail’* by Laurence Gardner

These two books were published in 1996 and 1998. *'The Antichrist and A Cup of Tea'* has been banned in the UK since it was first released. In a subsequent part of this series I will provide greater detail about Prince William revealing that he is the one who will soon be announced as Anti-Messiah! This is an incredible tale.

When the church pledged itself in perpetuity to the Merovingian bloodline in 496 A.D., it was presumably in full knowledge of their claimed identity. This would explain why Clovis was offered the status of Holy Roman Emperor, and why he was not created but "crowned" king. In 754 A.D. the church clandestinely betrayed its pact.

The Prieure de Sion is the name of the secret Charlemagne was the oldest son of Pepin the Short and Bertrada of Laon. He became king in 768 A.D. following his father's death, initially as co-ruler with his brother Carloman I. Carloman's sudden death in 771 A.D. in unexplained circumstances left Charlemagne as the undisputed ruler of the Frankish Kingdom. He continued his father's policy towards the papacy and became its protector, removing the Lombards from power in northern Italy and leading an incursion into Muslim Spain. He campaigned against the Saxons to his east, Christianizing them upon penalty of death and leading to events such as the Massacre of Verden. Charlemagne reached the height of his power in 800 A.D. when he was crowned Emperor of the Romans by Pope Leo III on Christmas Day at Old St. Peter's Basilica order which created the Knights Templars as its military and administrative arm. It should be remembered that the Knights Templars were the forerunners of Freemasonry. The Prieure de Sion continues to function through the centuries, acting in the shadows, and has orchestrated certain critical events in Western history.

It exists today and is still operative. Its declared objective is the restoration of the Merovingian dynasty and bloodline, to the throne of France, but of other European nations as well. This is a restoration that is sanctioned and justifiable, both legally and morally. There is strong evidence to suggest that this order was the author of Freemasonry, and "The Protocols of the Learned Elders of Sion", as well as the Rosicrucians and even the Jesuits. Jesuitism infiltrated all the secret societies early on as deemed necessary for the Jesuits to gain the upper hand and control of the Vatican and the Roman Catholic Institution.

There is abundant evidence to suggest that Nostradamus was one of their secret agents, and there is no question that numerous quatrains which refer to the advent of "*le Grand Monarch*" indicates that this sovereign will ultimately derive from the Merovingian dynasty. Implying a double hegemony of the Papacy and the Empire, of the Vatican and of the Habsburgs. He frequently referred quite explicitly to the Knights Templars and to the house of Lorraine which is now synonymous with the Habsburgs.



Although deposed in the 8<sup>th</sup> century, the Merovingian bloodline did not go extinct. On the contrary it perpetuated itself in a direct line from Dagobert II and his son Sigisbert IV. By dynastic alliances and intermarriages, this line came to include Godroi de Bouillon, who captured Jerusalem in 1099 A.D., and various other noble and royal families, past and present – Blanchefort, Gisors, Saint-Clair (Sinclair in England), Montesquieu, Montpezat, Poher, Luisighan, Plantard and Habsburg-Lorraine. At present, the Merovingian bloodline enjoys a legitimate claim to its heritage.

The crown of Charlemagne – a replica of which is now part of the imperial Habsburg regalia, and is said to bear the inscription “Rex Salomon”. The 14<sup>th</sup> Edition of the Encyclopedia published in 1972 has a picture of the crown of Charlemagne.

The “Spear of Destiny”, which is said to have pierced Jesus Christ, resides today in the Treasure House in Vienna, Austria, awaiting another Holy Roman Emperor. It is clear why the “Protocols of the Elders of Sion” speak of a new king “of the Holy seed of David”, noted in *‘Holy Blood and the Holy Grail’* by Bagent, Leigh, and Lincoln.

Otto von Habsburg is today the titular Duke of Lorraine and King of Jerusalem. The Priore de Sion claim to hold the lost treasure of the Temple of Jerusalem plundered by Titus in 70 A.D. which would be returned to Israel “when the time was right”. This may explain why Rome must defer to the “kings of the earth” and how she will seal a covenant with the Jews who have long hidden behind the shield of baptism.

Prince Bernhard of the Netherlands is in fact related to the Khazars, and therefore is a Gentile.

Revelation 2:9:

***“I know thy works and tribulation, and poverty, but you are rich, and I know the blasphemy of them which say they are Jews, and are not, but are the synagogue of Satan.”***

Revelation 3:9:

***“Behold, I will make them of the synagogue of Satan, which say they are Jews, and are not, but do lie; behold, I will make them to come and worship before thy feet, and to know that I have loved thee.”***

With the assistance of the CIA, Prince Bernhard brought the hidden ruling body of the Illuminati into public knowledge as the Bilderberg Group. It was formally established in 1954 and known by the name of the hotel of their first gathering as a ruling body. (Its headquarters is 1 Smidswater, Den Haag, Netherlands).

At the heart of the Bilderberg Group are 39 members of the Illuminati chosen from three blocs drawn from the members of all the secret groups that comprise the Illuminati:

- The Freemasons
- The Vatican
- The Black Nobility

This committee works year round in offices in Switzerland. The "Committee of 300" now call themselves the World Government Founders for the New World Order, a reference no doubt to their hereditary claim to the "Divine Right of Kings". It is imperative that we realize that privately, the "Black Nobility" refuse to ever recognize any government other than their own inherited and divine right to rule. They believe the United States still belongs to England and they work diligently behind the scenes to cause conditions whereby they might regain their crowns.

Every royal and so-called noble dynasty past and present of Europe have seats on the Committee of 300, most often by nominees. There are just too many of these so-called "royal" families for them each to have representatives on the Committee of 300. Precedence is determined by rank: first royal families, family members, then dukes, earls, marquise and lords, then finally "commoners", who usually get the title of "Sir".

In part 6 of this series we will examine the "Merovingian Bloodline" and the major names of the "Black Nobility".
